What is Domestic Violence?

Domestic Violence is a pattern of physical, emotional, verbal, financial and/or sexual abuse to gain power and control within a relationship. A relationship can involve a partner, family member or caretaker.

Does Your Partner...

Get jealous easily?

Blame others for their problems?

Threaten to hurt you, your loved ones, or pets?
Physically, emotionally or verbally abuse you?

What is Sexual Assault?

Sexual assault is any unwanted sexual contact that includes rape, attempted rape, intentional sexual touching, incest or molestation. It is committed without consent and often through the use of force, intimidation or coercion. Assailants can be strangers, spouses, acquaintances, friends, family members or anyone else. Sexual assault is not about sexual desire, it is about power and control.

You may experience...

<u>Physical reactions</u>: aches and pains, irritation, illness, stomach pains

<u>Emotional reactions</u>: shock and disbelief, fear, anger, powerlessness, and self blame

Mental reactions: difficulty making decisions, flashbacks, confusion

Bristol County District Attorney's Office

The Bristol County District Attorney's Office is responsible for the enhanced prosecution of domestic violence and sexual assault offenders. The Assistant District Attorneys and Victim Witness Advocates are specially trained to prosecute these cases. Each case is prosecuted by a team (prosecutor/advocate) assigned to the case from arraignment through disposition. You can reach the Prosecutor or Advocate assigned to prosecute your case by contacting the office. They will be able to explain the criminal process to you, explain the status of the case, assist you with a victim witness impact statement and provide you with resources including contacting the partnering agencies. Your Local Police Department

Your local police department has a Civilian Police Advocate available daily to assist victims of domestic violence, sexual assault, and stalking. The advocate follows up on each case and offers confidential free services providing safety planning, referrals and resources.

SAFEPLAN provides specially trained and certified advocates to offer in-court advocacy and support services to victims of domestic violence who are seeking intervention and protection through the court system. SAFEPLAN advocates can be located in the district and probate courts throughout Bristol County.

Massachusetts Parole Board Victim Services Unit

Parole is when an offender serves the remainder of the committed sentence in the community under supervision. This unit provides victims with information pertaining to an offender's post-conviction status. Services provided include but are not limited to: assisting victims of crime obtain certification for notifications, providing information regarding the parole process, submission of victim input, notification of parole hearings where victims are allowed to attend and participate, crisis intervention, safety planning, and referrals to community agencies. Bristol County Sheriff's Department Victim Services Unit

Post-conviction services begin when an offender has been sentenced to a term of incarceration. The unit provides information and assistance to victims of all crimes with services including: referrals and support services, answering questions and concerns related to an offender's incarceration, assistance to better understand the corrections process, phone blocks to prevent the offender from calling, safety planning, and becoming certified to receive pertinent information regarding the offender.

Children's Advocacy Center

The Child Advocacy Center (C.A.C.) is an interagency, multi-disciplinary partnership dedicated to minimizing trauma to children and families when concerns of abuse arise. Children in Bristol County between the ages of 3 and 18 who are the victims of sexual abuse, physical abuse or severe neglect receive coordinated services from a multi-disciplinary team. The Center provides extensive services to children and their families, including linkage to mental health services, domestic violence centers, and rape crisis centers. Victim Support Advocates provide investigation updates, support, and court accompaniment. The center provides specialized counseling referrals and outreach services as needed per each case. Sexual Assault Nurse Examiner (S.A.N.E.)

Quality medical care and evidence collection from specially trained Sexual Assault Nurse Examiners at designated SANE sites can be done within 120 hours of an assault. The following hospitals are SANE sites in Bristol County: St. Luke's and Morton. You may receive medical care and evidence collection without being required to report the crime to police. Bristol County CAC has a Pediatric SANE who is trained to conduct sexual abuse exams for children. www.mass.gov/dph/fch/sane/index.html

High Point Treatment Center's Intimate Partner Abuse Education Program

The program strives to end domestic violence by providing educational groups for batterers and resource information to partners and victims. The program curricula examines all forms of abusive behavior, the impact on intimate partners and children, and the cultural and social influences that contribute to violence. Female and male co-facilitators encourage batterers to adopt respectful and non-abusive behaviors toward their intimate partners and children, in part by modeling equal relationships. Abuse and control are viewed as the primary problems, unlike anger management programs where anger is viewed as the primary problem. Groups are typically held for 2 hours, once a week for 40 consecutive weeks. *Also available in Spanish. (508) 717-0522

South Coastal Counties Legal Services, Inc. (SCCLS)

SCCLS is a private, non-profit law firm providing legal assistance to eligible low-income clients in civil (non-criminal) matters, without charge, including but not limited to, domestic and sexual violence, housing (tenants only), custody, benefits, divorce, immigration and elder matters.
